1. General Information

Rwanda is a sovereign state in Central and East Africa and one of the smallest countries on the African mainland. Located a few degrees south of the Equator, Rwanda is bordered by Uganda, Tanzania, Burundi and the Democratic Republic of the Congo. Rwanda's economy suffered heavily during the 1994 Rwandan Genocide, but has since strengthened. The economy is based mostly on subsistence agriculture. Coffee and tea are the major cash crops for export. Tourism (especially for mountain gorilla viewings) is a fast-growing sector and is the country's leading foreign exchange earner.



Africa's most densely populated country is trying to overcome the limitations of its small, landlocked economy by leveraging regional trade; Rwanda joined the East African Community and is aligning its budget, trade, and immigration policies with its regional partners. The Rwandan Government is seeking to become a regional leader in information and communication technologies. In 2012, Rwanda completed the first modern Special Economic Zone (SEZ) in Kigali. The SEZ seeks to attract investment in all sectors, but specifically in agribusiness, information and communications, trade and logistics, mining, and construction (CIA Factbook, 2017). Also, interestingly, 56% of Rwandan MPs are female—the highest share in the world (Economist, 2017).

	RWANDA SWOT ANALYSIS
Strengths	 High public investment and expanding private consumption have underpinned impressive economic growth in the past decade. Inflation remains moderate in comparison with volatile price growth witnessed in neighbouring East African countries. Rwanda has enjoyed relative political stability since the end of the civil war and genocide in 1994.
	Moderate inflation has meant that the country has avoided an outbreak of popular protests over the rise in food and oil prices, unlike several neighbouring nations.
Weaknesses	 The majority of the population rely on agriculture for income, a sector which is vulnerable to adverse weather conditions. Rwanda's fiscal position is still heavily reliant on donor grants, which account for a large share of government income. Strong ethnic divisions between Hutus and Tutsis still exist, and memories of the genocide continue to blight the nation's international image. There is a perception among Hutu groups that the ruling Rwandan Patriotic Front party is heavily biased in favour of Tutsi interests. Perceptions of an institutional marginalisation of any group needs to be thoroughly addressed to prevent resentment.
Opportunities	 Rwanda has a growing tourism sector owing to the country's unique wildlife and vast swathes of national parks. Considerable investment opportunities exist in low and high-end accommodation as well as in infrastructure. Rwanda's Lake Kivu has huge energy-generating potential, which is beginning to attract the interest of a number of foreign companies. Continued stability relative to its peers may afford Rwanda the chance to play a more prominent role in the East African Community. Strong economic growth and improving living standards will reduce political risks.
Threats	 Agricultural output is highly dependent on weather conditions. Poor rainfall would severely hamper economic growth. A sharp reduction of aid would lead to considerable cutbacks in government spending or force at least a modest ramp up in debt. President Paul Kagame's decision to run for a third term following a constitutional change and referendum may cause a power vacuum over a multiyear timeframe.

2. Trade

South African trade with Rwanda

- Between 2007 and 2016, South Africa was the more dominant trade partner and recorded consecutive trade surpluses.
- South Africa's exports had a compound annual average growth rate of negative 3% from 2012 to 2016 and the imports had a negative growth of 32% for the same period.
- In 2016, South African exports to Rwanda were USD29million and imports were USD842 000.

- Insecticide and herbicide, USD4.4m
- Tractors, USD2.7m (there were no exports in this category in the 5yrs prior)
- Motor vehicles for the transport of goods USD2.5m

3. Foreign Direct Investment

Between January 2003 and June 2017 a total of 3 FDI projects were recorded from Rwanda. These projects represent a total capital investment of USD37.30m which is an average investment of USD12.40m per project. During the period, a total of 46 jobs were created.
